Brief discussion about the ALIA Futures project. The Futures project will help the Board determine the focus of ALIA.






Figure 1 & 2: Brainstorming notes taken at ACT ALIA Futures Workshop, 10 September 2013.

Question 1: What are our major challenges/issues?

Connection:

Issues raised surrounded training, skills and qualifications of staff, keeping up with changing technologies, funding issues, closing down of libraries, service delivery methods, online vs physical spaces and social justice/equity of access to information in which libraries play a fundamental role in communities/society.

It was identified how important libraries are in connecting people, ideas and allowing thinking and inspiration.

Convergence:

Challenges include joint use libraries already in use, changes to collections (including digital) and libraries no longer the 'only' place to go for information.

Golden Age of Information:

Issues raised included technological advances, hand held devices, information sources, privacy issues, copyright issues, cost of information.

Question 2: How should we respond? What are our priorities?

ALRC was identified as being a major priority in the near future. Accreditation, advocacy and digital literacy were also seen as high priorities. One ALIA member commented that ALIA should focus on one or two areas and 'do them really well.' It was advised that value, perceptions and advocacy were important to focus on.

Summary, any other business

- Aileen read the values of ALIA: fundamental business of libraries.
- 'Survival through relevance.'
- Vast majority of Australians are able to get more information than ever.
 Important to be visibly meeting needs.
- 'Assume discovery happens elsewhere and focus on fulfillment.'
- 'Convergence' is used in a different way in this paper than it has been used in the library industry in the last few years.
- New corporate membership of ALIA very welcome.
- ALRC fundamental issue in the next 12 months. Copyright and privacy issues.
- Digital citizenship advocacy for all having access to information.
- Libraries represent the key things people expect out of society.
- Information will be more expensive. Free information is becoming less common.
- Getting information from the Internet is like trying to take a drink from a fire hydrant"
