

JULY MEETING REPORT

The meeting was attended by 30 people and began with a farewell presentation to Pat Nakouz former Chief Librarian, Victorian Department of Health, by Veronica Delafosse. Many of Pat's colleagues joined in wishing her well in her retirement and thanking her for assistance and inspiration.

Jenny Waddell the Victorian co-ordinator for HEAPS (Health Education and Promotion System) then spoke on the development of HEAPS throughout Australia. HEAPS is a directory of health education and health promotion programmes which are currently running or have been run in the past. The HEAPS database can only be accessed via MEDLINE.

Improvements to HEAPS are being planned by increasing the coverage of the database; updating records every 6 months or so to keep contact names and evaluation of programmes current; and simplifying the data collection forms to include pertinent questions only. A manual for searching HEAPS is in progress and should be available by October 1987. Jenny distributed literature on HEAPS, including some search exercises.

COMBINED PRESENTATION TO LAW LIBRARIAN'S GROUP : MLS AND WHIG

Aina Zalitis (VCI) and Judy Czuchnowski (RMH:SON) represented MLS Vic Group in a panel discussion with Helen Scott (Brotherhood of St. Lawrence) and Ruth Harrison (Family Action) at a Law Librarian's Group meeting in May.

Aina opened the session with an overview of: the medical library system in Victoria; the variety of indexing and abstracting services supporting medicine; and the most frequently used databases. Judy then followed with a description of existing health networks including CMLO, RMLS and HEAPS. Judy also outlined the proposed ILL co-operative scheme based on GRATIS/SA.

Ruth Harrison first spoke on the networking of the Welfare and Health Information Group. Members are using Inmagic software and are swapping floppy disks to gain access to each others holdings. Ruth then discussed the library services at Family Action. Her clients are generally social workers throughout Victoria so contact with them is usually by mail. ILL requests are guaranteed to be delivered within four days of requests being received. Databases used include DHSS (London), Social Work Research and Abstracts (USA), FAMTLY, Australian Education Index and APAIS.

Helen Scott outlined the services of the Brotherhood of St. Lawrence Library. The library is open to the public and aims to collect material related to disadvantaged people in Australia.

Susan Sandford (Secretary, LLG) closed the meeting and thanked the guest speakers. Comments from those present suggested some envy at the degree of co-operation amongst medical libraries. The Law Librarians expressed their willingness to speak at an MLS meeting on a topic of interest.

Thanks go to Aina and Judy for preparing and presenting their talks and for representing MLS Vic Group.

QUALITY ASSURANCE SUB-COMMITTEE

A Quality Assurance Sub-Committee was established in May 1987 to look at the elusive concept of quality assurance in health science libraries. The Sub-Committee has met several times to evaluate the QA literature relating to libraries. It has accepted as its base document the AMA/ACHS Peer Review Resource Centre's publication, Quality assurance in hospital libraries: information kit. In addition, the Sub-Committee has identified a number of examples of QA programmes, most of which could be implemented quite simply. The Convenor of the QA Sub-Committee can provide details of where these examples can be found in the literature.

The Sub-Committee intends to file examples of QA programmes for libraries (particular) health science libraries). They would be delighted to hear from members who can contribute details of their own successful QA programme for sharing with other members

ALTERNATIVE ILL SCHEMES

Given the recent increase in ILL charges, libraries are looking to alternative schemes providing cheap or free copies and/or loans. Two such schemes currently being considered by health science libraries in Victoria are:

- 1) CMLO (Central Medical Libraries Organisation) ILL scheme
- 2) Victorian GRATIS ILL scheme

CMLO ILL scheme

Many CMLO members have expressed interest in a proposed scheme to obtain ILL photocopies and loans from University of Melbourne libraries at a cheap rate. The copies and loans would be made on behalf of CMLO participants by a person(s) employed by CMLO. A Working Party is developing a strategy to bring the scheme into effect. The anticipated cost of a loan or photocopy will be well under \$6.00.

Joan Martin is sending a letter to CMLO members asking them for details on their potential use of the scheme, taking into consideration the possible development of a Victroian GRATIS scheme (see below).

GRATIS/GRATISSA REVISITED

Last year, members were asked to express their interest in developing a free-of-charge ILL photocopy scheme, similar to the GRATIS scheme in NSW and the GRATISSA scheme in South Australia. Thirteen Victorian health science libraries, many of them hospital libraries, responded positively to the idea. At the time, this number was thought to be insufficient to create a viable scheme.

The broad aims of GRATIS/SA are:

- to maximise the use of the resources available in health science libraries, before approaching other sources
- to reduce demand on net lenders
- to provide a free and fast ILL service to other members
- to create and maintain a union list of periodicals held by participants in the scheme
- to have reciprocal rights with similar schemes

Any health science library, regardless of size of hours of operation, is welcome to join as long as they can meet the following criteria.

Members need to:

- supply a complete list of periodical holdings on joining the scheme, and provide an updated list annually, with six monthly supplements
- offer an adequate ILL service
- have a NUCOS locat-on symbol for easy and unique identification (there is no need to be a contributor to NUCOS to have a code assigned to your library)

GRATIS/GRATISSA REVISITED (CONT'D)

Each library is ranked as a first, second, third... resort library, depending on the size of their journal collection. Consideration is also given to any risk of over-use, especially where staffing is a severe problem.

The basic rule of operation is that members request ILL copies from a 'first resort' member capable of filling the request. Members with large collections are asked to supply material only if they are the sole source. Members are asked to not make excessive use of any one library. Requests which cannot be filled are returned immediately.

GRATIS and GRATISSA have been operating successfuly for several years. Members of these schemes are keen to see a similar operation in Victoria. Both networks would be willing to arrange reciprocal rights with VIC GRATIS.

professional pay rates

During the week beginning 20th July 1987, libraries at the following institutions were inspected by officials from our union (VAHPA), the Health Department of Victoria and the Department of Labour: Prince Henry's Hospital; Royal Melbourne Hospital; Queen Elizabeth Geriatric Centre; Austin Hospital; Alfred Hospital; Cancer Institute; and Royal Children's Hospital. The libraries were chosen to include specialised and general hospitals, to allow the interviewing of librarians with a range of qualifications, to illustrate the variety of library services and collections, and to identify the commons skills Librarians use to manage information. The meeting of the officials involved in the inspections took place on 3rd August. Our union is confident that the claim for professional or 'science rates' will be found to have merit i.e. that the skills and responsibilities of Librarians are comparable to those groups already being paid 'science rates'. However movement towards deciding the rates of pay, and the approval of these rates will be more problematic, and progress will not be known for at least another month.

Union rationalisations

It is the policy of the ACTU, Federal Government and business lobby groups that unions are to be reduced in number. Because unions without access to federal registration have a very bleak future, VAHPA's Executive authorised the investigation of establishing an HEF 3 Branch for VAHPA members. Discussions have also been held with union representatives of the Medical Scientists and Hospital Pharmacists, groups also interested in the HEF 3 proposal. It should be stressed that there is no possibility of HEF Branches amalgamating into a single health union, nor of Branch members being called on to support the industrial action of the other Branches. As elections for office bearers are expected to be held soon, VAHPA members are urged to join HEF 3 now.

Enclosed with this Newsletter is an application form for VAHPA, and HEF 3. If you are already a VAHPA member, simply fill in the HEF application and return the form to VAHPA's offices at: P.O. Box 157 ABBOTSFORD VICTORIA 3067. VAHPA's union dues are \$169 p.a. for full-time employees, and there is no additional fee for joining HEF 3. Your union representatives, Elisabeth Giddy (phone 344-2398) and Kathy Hutton (phone 345-5109) would be pleased to answer any union queries.

EXPERIENCE SOUGHT BY VISITING CHINESE LIBRARIAN
